
The Vessels weight must be adequately supported. Mounting from a wall plate is insufficient. The Pre-charge is 1.5 Bar but due to transportation & storage the installer should check the Pre charge and if required calibrate to 2 -4 % less than the systems M.O.P. Best practice is to install the vessel in a vertical position with the feed pipe gradually rising to the vessel's bottom threaded connection. Vessels should be serviced every year, with inspection of the Air pre charge, amending the pressure if required along with inspection and tightening of the flange and bolts with a label placed on the product identifying the service technician, the date of service & the pre-charge.
